

(Preamble / Introduction). Whereas considering the poverty of the masses on the one hand and lack of right knowledge, correct information to general public on the other, the author of the Trust deemed it fit to

found a public charitable trust to cater to the rural poor through social welfare schemes and programmes and diffusion of knowledge to rural and sub-urban population in particular and all needy and deserving in general. Moreover considering the growth of mass media communication diverse technological innovations in the field of communication, complexity of the professional services, role and challenges of social transformation, demands on non-governmental organisations (NGO) for works of public utility, the above mentioned author deemed it fit to give an autonomous and legal entity for all and any actions relating to, connected with, incidental and auxiliary to social work, mass media, press apostolate, communication, technology, audio visual means and charitable activities.

The author of the trust after conducting social programmes undertaking charitable projects intended to promote social welfare and other activities of public utility without any man made barriers like caste, creed, religion, gender, political opinion, linguistic group and community. One of the dimensions of social work - is diffusion of information. Hence, the author of the trust deemed it opportune to promote mass media and communication of all types - in realising this project of public welfare and development. The author of the trust does not reserve any right for himself, but intends that this trust be of a public, charitable nature for all charitable, social, educational; humanitarian, philanthropic, environmental, and all that befits of non-governmental organisation and non-profit organization. The trustees shall make every effort to reach out in public service, keep the administration costs to the

minimum, collaborate as much with the government and other authorities, undertake social projects and diffuse all type of knowledge beneficial to the humanity. In pursuance of these and other objects the author of the trust entrusts the trust property in the hands of diverse trustees. The trustees shall be as far as possible from all walks of life, profession, and community in a representative character – in order to cater to all sections of humanity.

In realisation of this project the author has made over Rs.5000/- (Rupees five thousand only) to be held by the trustees in trust, hereinafter referred to as trust property which expression shall mean and include all other future contributions and assets, or of whatever type in cash or in kind and its legitimate accretions to the trusties to realise the object of the trust subject to all other rules and regulations.

The name of the trust shall be Carmel Jyothi - a registered public charitable non-governmental organisation. The name of the trust for all practical purposes, and for brevity sake shall be referred to as **CARMEL JYOTHI NGO**, in all its functional, executive, public references, names, letter heads, rubber stamps/ seals as the trustees from time to time deem fit and proper. The term 'the trust' is used for brevity sake in these presents.

The registered office shall be at Carmel Bhavan, VIII ward, Sogi Road, Hoovinahadagalli town, Hoovinahadagalli taluk, Bellary District, Karnataka. Moreover, the administrative office shall be as per the need, efficiency, area of function, in one or many place/s, in any part of India. The trustees may without prejudice to any law, as the case may be, shift the registered office to suit any or all the objects of the trust. The governing body of the trust is at liberty, as per this deed to open, run, close down, shift the administrative office, as they think fit and proper.

(i) to establish, promote, set-up, run, maintain, assist, finance support and/or aid to or help in the setting up and/or maintaining and/or running non-profit organisations, social service centers, yoga centers, schools and other institutions: orphanages, widow homes, lunatic asylums, poor houses or other establishments for relief and/or help to the poor, old and infirm people and/or destitutes.

(ii) To give, provide and/or render help and assistance in cash or kind, through advice, meditation, professional assistance, spiritual and psychological counselling to believers, non-believers, academicians, religious, poor, needy, sick, either financial, cultural, academic, religious, social, wholistic for men, women, children, backward classes, institutes etc.

4. If any one or more of the objects specified in these presents are held not to be objects of a public charitable nature, by any law or otherwise, the trustees shall not carry out such object or objects as if the same are not incorporated in these presents; but the validity of the trust created by these presents as a trust for public charitable purposes shall not be affected in any manner.

5. The financial year of the trust shall end on 31st March, every year provided that the Board of Trustees shall be at liberty to change the same from time to time if they so deem it fit and proper. The first financial year of the trust shall close on 31<sup>st</sup> March, 2005

6. The trustees from time to time shall augment the trust fund, corpus fund, endowment fund, education fund, building fund, charity fund and other funds and after meeting the expenses of, and incidental to, the management of the Trust Properties and of its schemes and projects decide the particular object or objects for which the income or corpus of the Trust Fund or Properties for the time being available shall be applied without prejudice to the intentions of the donors and the provisions of the income tax act 1961.

7. The trustees may accept any donation or contribution in cash or in kind from any person, firm, company, corporation, associations, institution or registered bodies for the furtherance of the objects of the trust or for any one or more of them upon such terms and conditions as they may in their absolute discretion think fit and which are not inconsistent with the objects of the trust. secretary and one treasurer and other functionaries for administrative purposes, who collectively are called board of trustees (governing body members) and for any meeting and decision the quorum shall be three of the board of trustees. The trustees may change the names of these functionaries if they deem fit and proper in line with any law applicable to NGO management/s.

Without affecting the generality of powers and functions of all the trustees to manage and administer the trust, the Board of Trustees shall have the following functions:

- (iv) To authorise any one or more trustees to hold any property or any fund or any investment of the trust subject however to the terms of these presents in such manner and subject to such terms and conditions, rules and regulations as the Board of Trustees may from time to time think fit and proper.

the said lands, hereditaments and premises and to insure houses and buildings against loss or damage by fire and/or other risks or to let, lease, make allowances to and arrangements with tenants, agriculturists and generally to deal with the said lands, hereditaments and premises as they may deem fit in their absolute discretion.

16. The trustees may appoint Secretaries, Managers, Lawyers, Solicitors, Auditors, Architects, Engineers, Surveyors, social workers or other professional / skilled / unskilled or other employees for the purpose of management and supervision of the Trust property, for collection of rents, effects and profits, for keeping the accounts and records and for other work or purpose of the trust.

17. The trustees may establish its office/s at such place or places and may change such places from time to time as branch office/s, administrative office/s, unit/s as they may think fit and may call them under any proper names: Indian, foreign, local language of a place; which shall form part of the trust, for all corporate representations, legal purposes, compliance of law and for juridical personality.

18. 20. The trustees may join, co-operate and amalgamate the trust created by these presents or any portion thereof with any other trust, society, charitable company or institution, NGO, having allied and or similar objects upon such terms as they may in their absolute discretion think fit.

21. The trustees atleast by two third majority, without prejudice to the nature of the general purpose of the trust may from time to time frame schemes and rules and regulations to decide the powers and functions of each member of the board; the board of trustees and, tenure of office, eligibility, and or to carry out the objects of the trust and for managing the affairs of the trust and otherwise for giving effect to the objects and purposes of the trust and to vary the same from time to time as the trustees may in their discretion deem fit and proper.

scheme, study, survey, social work to impose any condition or conditions to any subscription or donation made by them and to earmark any portion of the Trust Property or income for any particular object or objects.

24. The trustees may reimburse themselves and pay and discharge out of the Trust Fund all expenses incurred by them in or about the execution of their trusteeship or any of their duties under these presents including travelling expenses, but will not be entitled to any share, benefit, favour as a trustee.

25. All the trustees unless they voluntarily resign or otherwise decide, shall continue to be the trustees for life time or for definite period as the board of trustees decide and communicate in writing. The board of trustees may invite some men and women or offer trusteeship owing to experience, academic qualification or their significant contribution in any field for the general wellbeing of the humanity.

26. The total number of trustees shall not be less than three.

29. Three trustees at a meeting shall form a quorum for any meeting of the board of trustees. In general, plenary and other special meetings and as stipulated by the board of trustees, one-third members shall be the quorum. The board of trustees may augment the number of quorum, as per the need and importance of decisions and activities in so far as it does not undermine the general powers of the board of

trustees. In the event, wherein the quorum is more than five members, the quorum is deemed to be present, having waited ten more minutes, after the schedule time for the said meeting has lapsed.

30. The trustees for the time being shall elect from amongst them one Managing trustee and he shall hold office for three years, unless he resigns or refuses to act as Managing trustee or otherwise ceases to be a trustee.

31. All proceedings and questions and matters arising at the meeting of the trustees shall be decided by a majority of votes and in case of equality of votes the Managing trustee shall have a second or casting vote provided however that notwithstanding anything herein stated, no question dealing with the disposal of more than fifty percent of the corpus fund, or trust properties or investment of the corpus or any other major investment or decision - that affects the very security of trust properties - shall be decided except with the consent of the plenary session.

32. In case of difference of opinion between the trustees the opinion of the majority shall prevail and if the trustees are equally divided in any matter, the Managing trustee shall have a casting vote. In all types of disputes in relation to the trust, trusteeship, trust property, and other incidental matters, arbitration shall be preferred.

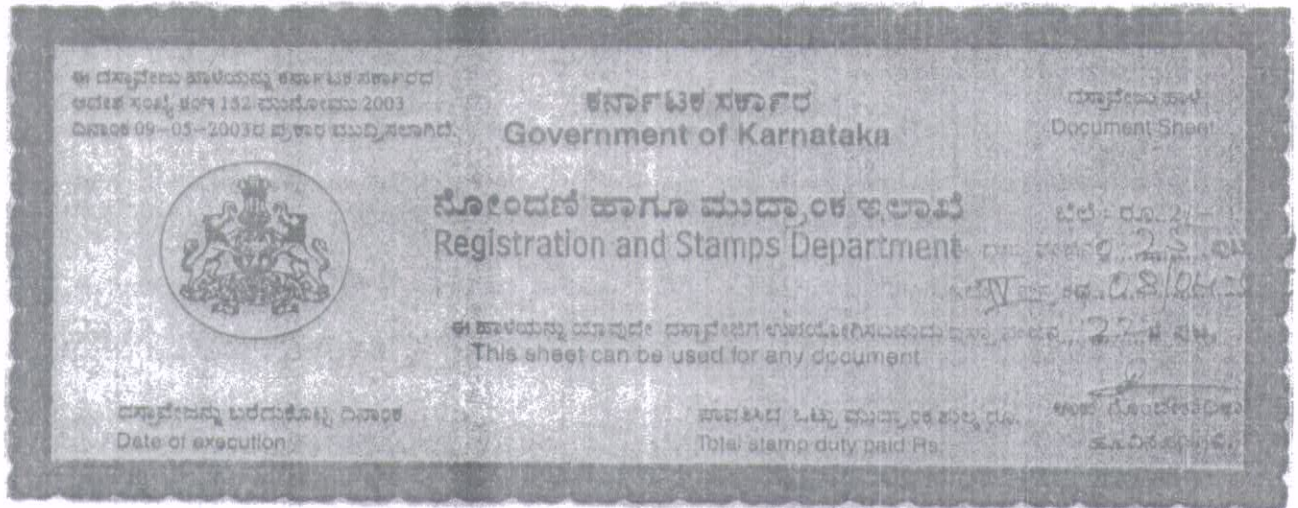

33. A resolution in writing circulated amongst all the trustees and signed by a majority of the trustees shall be as valid and effectual as if it had been passed at a

meeting of the trustees duly called and convened. For the ordinary and day today administration, if the decision of the board of trustees is required, the same could be done among all the members of the governing body of the trust called as board of trustees.

34. Notice of the meeting to the trustees and all communications may be sent to the addresses registered for the time being in the records of the trust. A simple communication through ordinary post given to the post office for dispatch, is deemed to have completed the service of notice.

35. All meetings of the trust shall be held at such place and at a such time as the Managing trustee or a simple majority of the trustees shall decide from time to time.

36. A trustee who is unable to be present at a meeting of the trustees may send his views on the agenda in writing and such expression of opinion shall be taken to be his vote on the matter concerned.

37. The minutes of the proceedings of every meeting of the trustees shall be entered in a book to be kept for that purpose/s and signed by the Managing trustee and another trustee preferably by the secretary of such meeting or of the following meeting when they are read over and shall when so entered and signed be conclusive evidence of the business and other matters transacted at such meeting.

- (ii) convicted of an offence involving moral turpitude; or
- (iii) of unsound mind; or
- (iv) a minor or
- (v) not of good repute in the opinion of the author / majority of the board of trustees shall be eligible to be a trustee.

39. The power to appoint new or additional trustees, but so as not to exceed the number unable to contact and defeats the objects of the trust; and to fill vacancies in the office of the trustees, shall vest in the continuing trustees or the board of trustees.

40. A person (male or female) shall cease to be a trustee in any of the following events:
- (a) if he dies; or
  - (b) if he becomes bankrupt; or
  - (c) if he becomes insane or otherwise become incapable to act; or
  - (d) if he resigns his office or
  - (e) if he harms in any way the interests of the trust
  - (f) if he does not carry out the legitimate decisions of the board of trustees
  - (g) if the three fourth majority of the board of trustees decide against the membership of a trustee for valid reason/s, having given notice in writing to that effect, may direct the trustee in question - to offer his / her resignation
  - (h) and as per paragraph no. 43.

42. The Board of Trustees shall be entitled to sue in the name of the trust and may similarly be sued in the name of the trust.

43. The Board of Trustees may, by a unanimous vote; and in the event when the board of trustees exceed ten, by absolute majority vote; of all the trustees for the time being except the trustee proposed to be removed, remove any trustee, permanent or otherwise, from office or from trusteeship, after finding the trustee proposed to be removed guilty of serious misconduct in relation to or concerning the trust property or trust affairs and after arriving at a definite conclusion that for the reasons to be recorded in writing the continuance of the trustee proposed to be removed as trustee of these presents was desirable keeping to the objects of the trust in view and other related or connected matters provided however that no conclusion of such guilt shall be arrived at without giving to the trustee proposed to be removed a full and fair opportunity of explaining his/her conduct and/or the charges levelled against him/her for his/her removal. And the decision of the Board of Trustees in this behalf shall be final and binding and shall not be called in question anywhere.

44. For clarity, comprehension, guidance, interpretation and certitude and in the event of doubt, if any object, provision, intention of the author is not incorporated in these presents, the same shall be deemed incorporated as it is found reflected in The Charitable and Religious Trusts Act, 1920 (Act of XIV 1920) as amended from time to time.

45. In all respects, referred above or otherwise, the objects of the trust, the functions of the trust, the role of trustees, the use of trust property, the carrying out of any project, the procuring of any benefit from the government in view of general public shall comply to any and all laws of the land, as amended from time to time. In any and every case, the intention of the donor shall be respected in respect of his or her donation / contribution to the trust.


